- *i.* To approve planning applications:
- Planning Application Consultation 22/02153/F. Proposed Store/Workshop building at Wildfowl and Wetlands Trust Hundred Foot Bank Welney Norfolk PE14 9TN, *overall approval however, The Council would like to following to be taken in to consideration.*
 - The plan is to build on 12 metre pilings, are we sure that these will not damage the sub structure of the river bank?
 - The site in question will be the initial view that visitors & commuters will see as they hit the brow of the bridge coming from Littleport. With this in mind would we be able to have some cottage like buildings (as per the two on main street opposite the Lamb & Flag)? This would have benefits to the village 1- They would match in with the initial surrounding properties i.e., the corner of Bedford Bank, the current building located on the bank, the Old Chapel, The Hives and of course the Pub, all of which are steeped in history.
 - The village already has an abundance of medium to high value properties within the village boundaries with the higher end being the new development at Old Croft Place, there is currently nothing in the village for first time buyer's starter homes other than social housing run by Freebridge.
- Planning Application Consultation 23/00179/O. OUTLINE APPLICATION Residential development (4 dwellings) at Former Three Tunns Public House Land N of Welney Parish Hall and E of Old Bedford Row Bedford Bank Welney Norfolk. Welney Planning Group advises approval of this application. The Council approved the decisions made.
- ii. **To discuss any celebration for the Kings Coronation:** *Cllr Harvey.* Prices and designs of Coronation mugs was discussed, also holding a street party at the William Marshal Centre. The Clerk will apply for the Borough Council Grant of £200 towards the cost. All other costs will come from the Playing Field Charity.
